CUSTOMER REWARDS PROGRAM RULES + REGULATIONS

1. Points are accumulated at the rate of **1 point per \$1.00** spent on food and beverages, excluding tax and gratuity.
2. Points are credited to your Mama Theresa's Rewards account when presenting your Rewards Card to any Mama Theresa's staff member **prior** to paying the bill.
3. Only the member paying the bill may accumulate points.
4. Members must be 18 years of age or older.
5. Reward points may not be used with any other promotion, offer or discount.
6. Members cannot receive points for purchases made prior to enrollment.
7. Points will **only** be issued if your Rewards Card is presented at the **time** and **date** of purchase.
8. Points have no cash value and may not be redeemed for cash or utilized towards gratuities.
9. Points are non-transferable or devisable, and may not be combined with another member's account.
10. Unused points **expire 18 months** from date of last transaction.
11. The changing nature of the restaurant industry requires that Mama Theresa's adapt and modify the program rules from time to time. Some changes may adversely affect the value of the points or awards already accumulated and the right to certain awards. We will notify the members of any such changes on our web site **www.MamaTherasas.com**. Your continued participation in this program constitutes consent to any such changes.
